By placing an order, you agree to the following:

#### 1. Company Details

#### 2. Scope

These terms apply to all orders placed via the MOM website. They take precedence over any other terms unless expressly agreed by Anthologist in writing.

#### 3. Our Products

- Stocked pieces: Available in limited quantities. Orders are confirmed subject to availability.
- Made-to-order pieces: Produced specifically for each order. Lead times vary and will be confirmed in writing. These items are non-cancellable and non-returnable.
- Please note: variations in colour, shape, or finish are part of the beauty of artisanal production and not considered defects.

#### 4. Orders

- All orders are placed through MOM and confirmed by Anthologist via email.
- Minimum order values, if relevant, are displayed on MOM or confirmed in writing.
- Once confirmed, orders cannot be cancelled unless agreed in writing by Anthologist.

#### 5. Pricing & Payment

- Prices are in EUR, exclusive of VAT, duties, and shipping unless stated otherwise.

- Payment terms are as displayed on MOM or stated on your invoice. Made-to-order pieces may require advance payment.
- Goods remain the property of Anthologist until full payment is received.

## 6. Delivery

- Delivery terms (Incoterms) are confirmed at order stage. Unless otherwise agreed, shipments leave Athens, Greece (EXW).

### Estimated lead times:

- Stocked items: typically [2-5 days] after confirmation.
- Made-to-order: timing varies by piece, shared at confirmation.
- We are not responsible for delays caused by carriers, customs, or force majeure events.

## 7. Inspection & Claims

- Please inspect goods on arrival.
- Claims for shortages, damage, or defects must be made in writing within 5 working days.
- For handmade goods, natural irregularities are considered intrinsic to the design.

## 8. Returns

- Stocked items: returns are accepted only with prior approval and at the Buyer's cost.
- Made-to-order items: final sale, no returns or refunds.

## 9. Liability

Our liability is limited to the replacement or refund of any defective goods supplied. We cannot accept responsibility for indirect or consequential losses.

## 10. Intellectual Property

All Anthologist designs, imagery, and written content remain our intellectual property. Reproduction is not permitted without our written consent.

## 11. Governing Law

These terms are governed by the laws of Greece. Any disputes will fall under the exclusive jurisdiction of the courts of Athens.
