### **1. Introduction**

These Terms & Conditions (“Terms”) govern all sales, wholesale agreements, and use of products and services provided by Fine Greek Jewelry (“Company”, “we”, “our”, “us”). By placing an order or conducting business with us, you agree to be bound by these Terms.

### **2. Products & Craftsmanship**

**2.1** All jewelry pieces are handmade, one-of-a-kind creations sourced exclusively from select Greek designers and artisan brands.

**2.2** Each piece is crafted individually using traditional goldsmithing techniques. No two pieces are identical, including paired items such as earrings.

**2.3** We do not reproduce, recreate, or custom-make any jewelry. No similar products can be made once a piece is sold.

**2.4** All items are hallmarked, quality-checked, and responsibly produced.

### **3. Orders**

**3.1** Availability is limited and based strictly on current inventory.

**3.2** Once an item is sold, it cannot be remade or reordered exactly the same.

**3.3** Wholesale terms apply only where a separate agreement is established in writing.

### **4. Pricing & Payment**

**4.1** All prices are listed in EUR unless otherwise stated.

**4.2** Accepted payment methods include bank transfer, credit card, or other approved options.

**4.3** International buyers are responsible for import duties, taxes, and customs fees.

### **5. Shipping & Delivery**

**5.1** We ship worldwide using trusted carriers.

**5.2** Tracking information is provided where available.

**5.3** Risk transfers to the customer once the package is handed to the carrier.

## **6. Returns & Exchanges**

**6.1** Due to the one-of-a-kind nature of our jewelry, all sales are final.

**6.2** Returns are only accepted in cases of proven manufacturing defects, assessed at our discretion.

## **7. Repairs & Warranty**

**7.1** A 6-month craftsmanship warranty applies to manufacturing defects.

**7.2** Warranty does not cover normal wear, accidental damage, or improper care.

## **8. Intellectual Property**

All designs, images, descriptions, and branding are the exclusive intellectual property of the designers and Fine Greek Jewelry. No reproduction or commercial use is permitted.

## **9. Privacy**

We collect only the information necessary to process orders. We do not sell or share data except with shipping or payment partners.

## 10.Limitation of Liability

We are not liable for indirect or incidental damages, shipping delays, or misuse of jewelry. Liability is limited to the purchase amount.

## 11.Governing Law

The laws of Greece govern these Terms. The courts of Athens, Greece will handle all disputes.
