

B2B TERMS AND CONDITIONS OF SALE (MOM PLATFORM)

1. General Information

This commercial space is operated by DANIÉ (hereinafter the “Supplier”, “we”, “us”). These Terms and Conditions govern all sales made through the MOM platform of Maison & Objet to professional clients (hereinafter the “Buyer” or “Customer”).

By placing an order, the Customer fully accepts these Terms and Conditions.

2. B2B Nature of the Service

Sales are exclusively reserved for professional operators (retailers, distributors, companies).

The Customer confirms that purchases are made for business purposes and not as an end consumer.

Consumer protection regulations (such as withdrawal rights) do not apply.

3. Products and Availability

Products are described as accurately as possible.

However, variations (e.g. colors, finishes) may occur due to technical or artisanal reasons.

Product availability is not guaranteed and may change without prior notice.

4. Prices

All prices are expressed in Euros and are:

- excluding VAT (unless otherwise stated)
- excluding shipping costs, which will be defined at order stage

The Supplier reserves the right to change prices at any time prior to order confirmation.

5. Orders and Acceptance

Orders placed via the MOM platform are subject to acceptance by the Supplier. The Supplier reserves the right to refuse any order, limit quantities, or request additional information.

An order is considered confirmed only upon explicit acceptance by the Supplier.

6. Payment Terms

Payment terms will be agreed between the parties or specified at the time of order.

In case of late or failed payment, the Supplier reserves the right to suspend or cancel the order.

7. Shipping and Delivery

Shipping terms and Incoterms (EXW, FOB, DDP, etc.) will be agreed case by case.

Delivery times are indicative and not binding.

Delays do not entitle the Customer to compensation or cancellation.

8. Transfer of Risk

Risk transfers according to the agreed Incoterm.

The Customer must inspect goods upon delivery.

9. Claims and Returns

Claims must be submitted in writing within:

- 7 days for visible defects
- 30 days for hidden defects

Returns require prior written authorization and must be unused.

10. Limitation of Liability

The Supplier is not liable for indirect damages or loss of profit.
Liability is limited to the value of the goods supplied.

11. Intellectual Property

All content remains the exclusive property of the Supplier.
Unauthorized use is prohibited.

12. Force Majeure

The Supplier is not responsible for delays due to force majeure events.

13. Governing Law

These Terms are governed by Italian law.
Jurisdiction is that of the Supplier's registered office.

14. Amendments

The Supplier may update these Terms at any time.
Changes apply to future orders.
