These conditions of sale are concluded between the company **COTTONPASSION LDA**, whose registered office is located at **R GERVASIO LOBATO 4, 2820-624, CHARNECA DA CAPARICA, PORTUGAL**, registered under number **519039220**, hereinafter referred to as "**Maraletto**", and any professional buyer on mom.maison-objet.com, hereinafter referred to as "the buyer".

Article 1. Purpose

These T&Cs define the contractual relationship between **Maraletto** and the buyer for any purchase made on mom.maison-objet.com. Purchasing a product implies unreserved acceptance of these terms.

Maraletto reserves the right to modify these conditions at any time. The applicable conditions are those in force on the date of the order.

Article 2. Products

The products offered are those listed on mom.maison-objet.com by **Maraletto**, subject to availability. Photographs are for illustrative purposes only and are not binding. The buyer acknowledges that colours, textures, finishes and dimensions may vary slightly from product images, screen rendering, samples or previous batches. Such minor variations shall not constitute non-conformity provided the product remains substantially consistent with its description. Sales are reserved for professional buyers authorised to import these products into their country.

Article 3. Prices

Prices are in Euros (€) excluding taxes (excl. VAT). VAT is added at the time of ordering. **Maraletto** reserves the right to modify its prices at any time; the applicable price is the one displayed at the time of the order. Delivery costs are charged separately.

Article 4. Order & Payment

The buyer must have an account on mom.maison-objet.com to place an order. Two payment methods are available:

- VISA / MASTERCARD credit card — immediate debit, secured via 3D Secure.
- SEPA bank transfer — the order is processed upon receipt of the transfer by SAFI.

Order confirmation constitutes acceptance of these T&Cs. If payment fails or is refused, the order is cancelled. For any enquiry, contact Maison & Objet — MOM Marketplace: mom.maison-objet.com

Article 5. Reservation of ownership

Maraletto retains full ownership of the products sold until full payment of the price, including all costs and taxes.

Article 6. Delivery

Deliveries are made to the address indicated on the order. Shipments are handled by **PostNL** with tracking. Shipments are generally handled by PostNL with tracking where available. However, **Maraletto** reserves the right, at its sole discretion, to use any other carrier, freight forwarder or logistics provider for all or part of the shipment, in particular where required by destination, parcel size, service availability, operational constraints, customs requirements or force majeure, without this constituting a modification of the order or giving rise to any claim by the buyer.

Delivery times are indicative. If the delivery exceeds 30 days from the order date, the buyer may cancel the sales contract and be reimbursed. Unless otherwise agreed in writing, customs duties, import taxes, brokerage fees and local charges in the destination country are borne exclusively by the buyer. Delivery times are indicative and do not constitute a firm commitment unless expressly confirmed in writing.

Upon receipt, the buyer must open the parcel in the presence of the carrier and check its contents. Any damage must be reported immediately to the carrier, with written reservations on the delivery note. Failing this, the goods are deemed accepted without reservation and transport liability is transferred to the buyer.

Orders are firm and non-cancellable once confirmed, except with Maraletto's prior written agreement. Custom, personalised, made-to-order or limited-edition products cannot be cancelled or returned once production has started, unless legally required or unless the product is proven defective or non-conforming.

Article 7. Guarantee

All products supplied by **Maraletto** benefit from the legal guarantee (articles 1641 et seq. of the French Civil Code). Any complaint must be addressed to Maison & Objet — MOM Marketplace within the stipulated period, i.e. **D+10 from the shipment date of the goods**.

Article 8. Liability

In the context of distance selling, **Maraletto's** liability is limited to best-efforts obligations. It cannot be held liable for damages resulting from internet use (data loss, viruses, service interruption).

Article 9. Intellectual property

All elements of the mom.maison-objet.com website are the exclusive intellectual property of Maison & Objet. Any reproduction, even partial, is prohibited without prior authorisation.

All elements, content, trademarks, logos, visuals, photographs, texts, product names, designs and other materials relating to Maraletto and its products remain the exclusive property of Maraletto.

Nothing in these T&Cs shall be construed as transferring any intellectual property right to the buyer.

The buyer may not reproduce, adapt, modify, register, distribute or otherwise use Maraletto's trademarks, visuals or content without Maraletto's prior written consent, except to the extent strictly necessary for the resale promotion of authentic Maraletto products lawfully purchased from Maraletto and only for the duration of the commercial relationship.

Any use of Maraletto's content by the buyer must be accurate, non-misleading, respectful of the brand image and immediately cease upon Maraletto's request.

Article 10. Personal data

Maison & Objet undertakes to preserve the confidentiality of information provided by the buyer, in accordance with French Law No. 78-17 of 6 January 1978. The buyer has the right to access, modify and delete their data: exercervosdroits@safisalons.fr

Article 11. Dispute resolution
